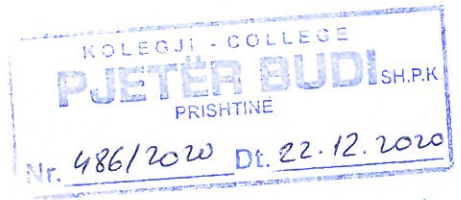

Pursuant to Article 104 of the Statute of the College "Pjetër Budi, the Steering Board of the College on the date 28.12. 2020, approved the following:

## **REGULATION FOR THE STUDENT PARLIAMENT**

### **Article 1**

#### **Profile of Parliament**

The Student Parliament is a student organization, which is committed to educational issues, student interests and their well-being.

The Student Parliament is known as the Pjetër Budi College Student Parliament.

The Student Parliament represents students inside and outside the college. Organizes events and activities of interest to students which are related to their development opportunities.

Parliament all the time demands that there be diversity and equality of members without gender, religious, political, social and sexual orientation.

The Student Parliament will work to protect and enhance students' right to free speech.

## **Article 2**

### **Student organization**

Students have the right to establish student organizations to which all students can belong.

Each student organization has its own statute that is approved by its members in accordance with the general regulations issued by the Governing Board. The statute will include the principles of equal opportunities and non-discrimination.

## **Article 3**

### **Student representative bodies**

The interests of the students will be represented within the College with the following bodies:

Student Parliament at the College level;

Student Council at the level of Study Programs.

## **Article 4**

Members of the Student Parliament and student councils shall be elected in accordance with the procedures for parliamentary elections.

Student organizations have the right to nominate members to the Student Parliament and Student Council of the Study Program based on the election results every two years.

The mandate of the members of the Student Parliament and the student council of the Study Program lasts 2 years, without the right of re-election.

The Student Parliament and the Student Council student councils exercise their duties in accordance with the principle of majority voting.

#### **Article 5**

The Student Parliament is the supreme body of student representation.

The total number of members of the student parliament is 7.

Members are nominated by student organizations based on the total number of votes cast in the student elections and according to the priority lists of candidates published by each student organization at the beginning of the election campaign.

Members of the Student Parliament elect the chairman and vice-chairman.

The Governing Board issues the rules of procedure for the student parliament.

The Student Parliament elects the members of the Senate from a list of nominees prepared by the Student Program Student Council. The Speaker of the Student Parliament is an exofficio member from the total number of student members of the Senate.

#### **Article 6**

Student councils are the student representation bodies in each study program.

The total number of members of each student council is 1% of the total number of full-time students enrolled in that study program, with a minimum of 1 and a maximum of 3 members.

Members will be nominated by the student organization based on the total number of votes received during the student elections for each study program according to the priority lists of candidates published by the student organization at the beginning of the election campaign.

The members of each student council elect a chairman and a vice-chairman.

Each student council proposes the list of candidates for student members of the Senate to be elected by the Student Parliament.

The Governing Board allocates an appropriate annual budget for the activities of the Student Parliament and student councils proposed by the Student Parliament.

#### Article 8

Students are entitled to peaceful assembly.

#### Article 9

Students have the right to form professional associations or associations for any purpose permitted by the Law on Higher Education of Kosovo.

#### Article 10

- This new regulation repeals the old regulation on salaries and working hours of academic staff.

This regulation enters into force on the day of signing by the President of the Board of the College "Pjetër Budi" - Prishtina.
